We have performed the procedures enumerated below, which were agreed to by the Chairman of the Pickaway County Republican (Central and Executive) Committee, solely to comply with the requirements of Section 3517.17 of the Ohio Revised Code. The procedures and associated findings are as follows:

Cash Receipts

We confirmed the Ohio Political Party Fund receipts with the State of Ohio and agreed to amounts shown on the Political Party Fund Finance Report.

We found no exceptions as a result of our procedures.

Cash Reconciliation

We compared the sum of the cash balances recorded on the Committee's Political Party Fund Finance Report with cash balances recorded on the bank reconciliation for the Committee as of December 31, 1999. We recomputed the mathematical accuracy of the reconciliation.

We found no exceptions as a result of the procedures.

We were not engaged to, and did not, perform an audit, the objective of which would be the expression of an opinion on the political party fund finance report which is attached as Exhibit A. Accordingly, we do not express such an opinion. Had we performed additional procedures, other matters might have come to our attention that would have been reported to you.
