#### INDEPENDENT ACCOUNTANT'S REPORT

We have examined the Miami Valley Fire District, Montgomery County management's assertion that the census data and pensionable wages reported to the Ohio Police and Fire Pension Fund as of December 31, 2020, and for the year then ended was accurate and complete.

### Management asserts that:

- The census data provided to the Ohio Police and Fire Pension Fund as of December 31, 2020 is accurate and complete. Census data includes
  - First and Last Name;
  - o Last four digits of the social security number;
  - Contributions remitted to the plan;
  - o Pensionable Compensation.
- The census data provided to the Ohio Police and Fire Pension Fund as of December 31, 2020 included all enrolled employees.
- Census data changes occurring during the year ended December 31, 2020 to an enrolled employee's eligible compensation, were properly updated with the Ohio Police and Fire Pension Fund
- All employees required to be enrolled in the Ohio Police and Fire Pension Fund in accordance with statutory requirements were properly enrolled.
- The total pensionable wages and employee contributions information reported to the Ohio Police and Fire Pension Fund for the year ended December 31, 2020 agrees with the payroll records of the employer.

Miami Valley Fire District's management is responsible for the assertions. Our responsibility is to opine on management's assertions based on our examination.

Our examination was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants and the standards applicable to attestation engagements included in the Comptroller General of the United States' *Government Auditing Standards*. Those standards require
