BASIC AUDIT REPORT

University Heights City Beautiful Corporation
Cuyahoga County

We have completed certain procedures in accordance with Ohio Rev. Code Section 117.01(G) to the accounting records and related documents of the University Heights City Beautiful Corporation, Cuyahoga County, (the Corporation) for the years ended December 31, 2022 and 2021.

Our procedures were designed solely to satisfy the audit requirements of Ohio Rev. Code Section 117.11(A). Because our procedures were not designed to opine on the Corporation's financial statements, we did not follow *generally accepted auditing standards*. We do not provide any assurance on the Corporation's financial statements, transactions or balances for the years ended December 31, 2022 and 2021.

The Corporation's management is responsible for preparing and maintaining its accounting records and related documents. Our responsibility under Ohio Rev. Code Section 117.11(A) is to examine, analyze and inspect these records and documents.

Based on the results of our procedures, we found the following compliance issue to report.

Current Year Observation

1. The Corporation did not have a formal public records policy or records retention schedule. Ohio Rev. Code § 149.43(E)(2) requires an entity to adopt a public records policy. Ohio Rev. Code § 149.43(B)(2) requires an entity to have available a copy of its current records retention schedule at a location readily available to the public. Our prior engagement also reported this matter.

Current Status of Matters Reported in our Prior Engagement

2. In addition to the matter reported in item 1 above, our prior basic audit for the period December 10, 2018 to December 31, 2020 included an observation that the Corporation did not file a complete annual financial report for the year ended December 31, 2018 on the Auditor State HINKLE System within the required 120 day deadline. This matter was resolved in the current period and complete reports for the years ended December 31, 2022 and 2021 were filed within the prescribed deadline.
