### **BASIC AUDIT REPORT**

Village of Pleasant Plain Warren County Pleasant Plain, Ohio 45162

We have completed certain procedures in accordance with Ohio Rev. Code Section 117.01(G) to the accounting records and related documents of the Village of Pleasant Plain, Warren County, (the Village) for the years ended December 31, 2022 and 2021.

Our procedures were designed solely to satisfy the audit requirements of Ohio Rev. Code Section 117.11(A). Because our procedures were not designed to opine on the Village's financial statements, we did not follow *generally accepted auditing standards*. We do not provide any assurance on the Village's financial statements, transactions or balances for the years ended December 31, 2022 and 2021.

The Village's management is responsible for preparing and maintaining its accounting records and related documents. Our responsibility under Ohio Rev. Code Section 117.11(A) is to examine, analyze and inspect these records and documents.

Based on the results of our procedures, we found the following significant compliance or accounting issues to report.

### **Current Year Observations**

- 1. The Village elected officials, did not, during their term of office, attend a required Certified Public Records Training or have an appropriate designee attend a training as required by Ohio Rev. Code 149.43(E)(1).
- 2. The Village did not have their public records policy displayed in all branches of the Village as required by Ohio Rev. Code 149.43(E)(2).
- 3. The Village did not have a records retention policy or schedule during the engagement period and did not make it readily available to the public as required by Ohio Rev. Code 149.43(B)(2).
- 4. The Village did not notify the general public of when public meetings are to be held, as required by Ohio Rev. Code 121.22(F). They are always the first Monday of the month, if there is a reschedule of this, they post the changed date, only.
- 5. We noted that the Village did not withhold or submit State income tax in accordance with Ohio Rev. Code § 5747.06, during the audit period. We recommend the Village withhold the required State income tax and remit them with any required employer match to the applicable agency.

This matter will be referred to the Ohio Department of Taxation.
