INDEPENDENT ACCOUNTANTS' REPORT ON APPLYING AGREED-UPON PROCEDURES

We have performed the procedures enumerated below, which were agreed to by the Republican Executive Committee, solely to assist the Committee in evaluating its compliance with Sections 3517.17 and 3517.18 of the Ohio Revised Code for the year ended December 31, 2004. Management is responsible for the Committee's compliance with those requirements. We followed the American Institute of Certified Public Accountants' attestation standards for agreed-upon procedures engagements. The sufficiency of the procedures is solely the responsibility of the Executive Committee. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

Cash Receipts

We confirmed the Ohio Political Party Fund receipts with the State of Ohio and agreed them to amounts shown on the Ohio Campaign Finance Report. We found no exceptions.

Cash Reconciliation

1. We compared the sum of the cash balances recorded on the Ohio Campaign Finance Report with the cash balances reconciled by David Tshantz, Treasurer for the Wayne County Republican Party as of December 31, 2004. The sums agreed.
2. We recomputed the mathematical accuracy of the reconciliation. We found no computational errors.
3. We agreed bank balances on the reconciliation with month end bank statements. The balances did not agree due to an electronic fund transfer in the amount of \$26.34 that was paid from the Wayne County Republican Party checking account on December 31, 2004 but was shown in the checkbook as being paid on January 3, 2005. The financial statements have been adjusted to record the \$26.34 as a disbursement during 2004.

Cash Disbursements

1. We footed the cash disbursements listed in the checkbook and compared the listing totals to the disbursement totals on the Ohio Campaign Finance Report. The amounts did not agree due to an electronic fund transfer in the amount of \$26.34 that was paid from the Wayne County Republican Party checking account on December 31, 2004 but was shown in the checkbook as being paid on January 3, 2005. The financial statements have been adjusted to record the \$26.34 as a disbursement during 2004.

2. We selected 100% of disbursement transactions and traced the payee and amount to source documentation such as invoices and electronic fund transfers (EFT). We also compared the payees on the EFT description on the bank statement to the names on the invoices. The payees and amounts recorded in the checkbook agreed to the payees and amounts on the EFT description on the bank statement.
3. We compared the purpose for the disbursement with the allowable uses described in Section 3517.18 of the Ohio Revised Code. We found no exceptions.

Payroll Disbursements

The Republican Party Executive Committee had no payroll cash disbursements during 2004.

We were not engaged to, and did not; perform an examination, the objective of which would be the expression of an opinion on compliance of the political party fund finance report which is attached to this report. Accordingly, we do not express such an opinion. Had we performed additional procedures, other matters might have come to our attention that we would have reported to you.
