Independent Accountants' Report on Applying Agreed-Upon Procedures

We have performed the procedures enumerated below, which were agreed to by the Ohio Department of Medicaid (ODM), on Dr. Carmela Abraham's (hereafter referred to as the Provider) compliance with the requirements of the Medicaid Provider Incentive Program (MPIP) for the year ended December 31, 2016. The Provider is responsible for compliance with the MPIP requirements. The sufficiency of these procedures is solely the responsibility of ODM. Consequently, we make no representation regarding the sufficiency of the procedures enumerated below either for the purpose for which this report has been requested or for any other purpose.

- 1. We obtained the group encounters during the patient volume attestation period from the Provider. We scanned the list and found no duplicate encounters. We also found that it included multiple payer sources.
- 2. We recalculated the Medicaid patient volume from the encounters identified in procedure 1 and confirmed the Provider met the 30 percent patient volume requirement.
- 3. We found the Provider's location was using the same electronic health record (EHR) system as reported in the MPIP system, but are now using a more current version.
- 4. We obtained the Provider's equipped practice locations during the meaningful use period. We found only one equipped practice location and compared it to the locations included in the meaningful use report. We found no exception.
- 5. We obtained supporting documentation for the 10 objectives and compared it to the applicable criteria. We found no exceptions.
 - We could not perform a scan of the detailed data for those measures that require only unique patients be counted as the Provider did not provide any unique patient data.
- We obtained supporting documentation for the clinical quality measures and compared it to the applicable criteria. We confirmed the minimum number of measures was met with at least one measure from three different domains.

This agreed-upon procedures engagement was conducted in accordance with the American Institute of Certified Public Accountants' attestation standards. We were not engaged to and did not conduct an examination or review, the objective of which would be the expression of an opinion or conclusion, respectively, on the Provider's compliance with the requirements of the Medicaid Provider Incentive Program. Accordingly, we do not express such an opinion or conclusion. Had we performed additional procedures, other matters might have come to our attention that would have been reported.
