## Independent Accountants' Report on Applying Agreed-Up Procedures

We have performed the procedures enumerated below, which were agreed to by the Ohio Department of Medicaid (ODM), on Dr. Abhay Sharma's (hereafter referred to as the Provider) compliance with the requirements of the Medicaid Promoting Interoperability Program (MPIP) for the year ended December 31, 2017. The Provider is responsible for compliance with the MPIP requirements. The sufficiency of these procedures is solely the responsibility of ODM. Consequently, we make no representation regarding the sufficiency of the procedures enumerated below either for the purpose for which this report has been requested or for any other purpose.

1. We obtained the Provider's encounters for the patient volume attestation period. After scanning the list, we removed duplicates and totaled the non-duplicated encounters. We also noted that the list included multiple payer sources. We recalculated the Medicaid patient volume and confirmed the Provider met the 30 percent requirement.
2. We compared the system generated dashboard to the applicable criteria and to the Meaningful Use Objectives and the Clinical Quality Measures Summaries. We noted that the dashboards did not contain the following objectives: Objectives 1: Security risk analysis, Objective 2: Clinical decision support and Objective 10: Public health. We found all reported objectives on the dashboard met the applicable criteria. We noted a variance greater than 10 percent with the Clinical Quality Measures dashboard when compared to the summary for one the CMS 124: Cervical cancer screening.

This agreed-upon procedures engagement was conducted in accordance with the American Institute of Certified Public Accountants' attestation standards. We were not engaged to and did not conduct an examination or review, the objective of which would be the expression of an opinion or conclusion, respectively, on the Provider's compliance with the requirements of the Medicaid Promoting Interoperability Program. Accordingly, we do not express such an opinion or conclusion. Had we performed additional procedures, other matters might have come to our attention that would have been reported. This report is intended solely for the information and use of the ODM, and is not intended to be, and should not be used by anyone other than the specified party.
