BASIC AUDIT REPORT

We have completed certain procedures in accordance with Ohio Rev. Code Section 117.01(G) to the accounting records and related documents of the Hillgrove Union Cemetery, Montgomery County, (the Cemetery) for the years ended December 31, 2022 and 2021.

Our procedures were designed solely to satisfy the audit requirements of Ohio Rev. Code Section 117.11(A). Because our procedures were not designed to opine on the Cemetery's financial statements, we did not follow *generally accepted auditing standards*. We do not provide any assurance on the Cemetery's financial statements, transactions or balances for the years ended December 31, 2022 and 2021.

The Cemetery's management is responsible for preparing and maintaining its accounting records and related documents. Our responsibility under Ohio Rev. Code Section 117.11(A) is to examine, analyze and inspect these records and documents.

Based on the results of our procedures, we found the following significant compliance issue to report.

Current Year Observation

Ohio Rev. Code §149.43(E)(2) requires the Cemetery to distribute its public records policy to the employee who has been designated as the records custodian/manager or otherwise has custody of the Cemetery's records. The employee is required to acknowledge receipt of the copy of the public records policy.

The Cemetery was unable to provide documentation supporting that the Cemetery's records custodian or records manager had received a copy of the Cemetery's public records policy.

Policies and procedures should be established and implemented to verify the Cemetery's compliance with all provisions of the Public Records Act.

Current Status of Matter Reported in our Prior Engagement

Our prior audit for the years ended December 31, 2020 and 2019 included an observation that the Cemetery did not conspicuously display its public records policy in its office or have written evidence its public records policy was provided to the records custodian. The Cemetery conspicuously displayed its public records policy in the cemetery office during the years ended December 31, 2022 and 2021 but did not obtain written evidence of the public records policy being provided to the records custodian, which has been included above as the Current Year Observation.
