BASIC AUDIT REPORT

We have completed certain procedures in accordance with Ohio Rev. Code Section 117.01(G) to the accounting records and related documents of the Liberty Township – Village of Liberty Center Joint Economic Development District, Henry County, (the JEDD) for the period January 1, 2021 through June 1, 2021.

Our procedures were designed solely to satisfy the audit requirements of Ohio Rev. Code Section 117.11(A). Because our procedures were not designed to opine on the JEDD's financial statements, we did not follow *generally accepted auditing standards*. We do not provide any assurance on the JEDD's financial statements, transactions or balances for the period January 1, 2021 through June 1, 2021.

The JEDD's management is responsible for preparing and maintaining its accounting records and related documents. Our responsibility under Ohio Rev. Code Section 117.11(A) is to examine, analyze and inspect these records and documents.

Based on the results of our procedures, we found the following significant compliance or accounting issues to report.

Current Year Observations

1. We inquired with JEDD's management and determined that the JEDD did not have a public records policy during the engagement period as required by **Ohio Rev. Code § 149.43(E)(2)**.

Because the JEDD did not have a public records policy during the engagement period, it therefore could not have displayed posters of said policy in all the branches of the JEDD as required by **Ohio Rev. Code § 149.43(E)(2)**. It could also not have provided a copy of the policy to the proper custodian or records manager as also required by **Ohio Rev. Code § 149.43(E)(2)**.

This could result in records requests not being fulfilled in accordance with Ohio law.

The JEDD shall establish a public records policy and may address the JEDD's available records, the times when public records may be inspected, and the costs associated with records requests. The policy shall be included in policy manuals and the Public Records Act requires that the policy be displayed conspicuously in all branches of the JEDD. In addition, the JEDD shall have written evidence that the Public Records Policy was provided to the records custodian/manager.

Furthermore, pursuant to **Ohio Rev. Code § 109.43(E)**, the Ohio Attorney General has developed and provided to all public offices a model public records policy for responding to public records requests. The policy, which is available at https://www.ohioattorneygeneral.gov/Files/Government_Entities/Model-Public-Records-Policy.aspx, provides guidance to public offices in developing their own policies for responding to public records requests in compliance with the Public Records Act.

2. We noted the JEDD does not have an adopted records retention schedule. It therefore cannot have a copy of said policy available to the public. Ohio Rev. Code § 149.43(B)(2) states, in part, a public office also "shall have available a copy of its current records retention schedule at a location readily available to the public." Failure to have and follow a records retention schedule could result in public records being disposed of prematurely. The JEDD should implement procedures to provide the appropriate policy is approved to help avoid issues with public records requests.
