**INDEPENDENT ACCOUNTANT'S REPORT ON APPLYING AGREED-UPON PROCEDURES**

We have performed the procedures enumerated below on the Mahoning County Soil and Water Conservation District's (the District) receipts, disbursements and balances recorded in the cash-basis accounting records for the years ended December 31, 2021 and 2020, and certain compliance requirements related to those transactions and balances, included in the information provided to us by the management of the District. The District is responsible for the receipts, disbursements and balances recorded in the cash basis accounting records for the years ended December 31, 2021 and 2020 and certain compliance requirements related to these transactions and balances included in the information provided to us by the District.

The Board of Supervisors and the management of the District have agreed to and acknowledged that the procedures performed are appropriate to meet the intended purpose of providing assistance in the evaluation of the District's receipts, disbursements and balances recorded in their cash-basis accounting records for the years ended December 31, 2021 and 2020, and certain compliance requirements related to these transactions and balances. Additionally, the Auditor of State has agreed to and acknowledged that the procedures performed are appropriate to meet their purposes. No other party acknowledged the appropriateness of the procedures. This report may not be suitable for any other purpose. The procedures performed may not address all the items of interest to a user of the report and may not meet the needs of all users of the report and, as such, users are responsible for determining whether the procedures performed are appropriate for their purposes. The sufficiency of the procedures is solely the responsibility of the parties specified in the report. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

For the purposes of performing these procedures, this report only describes exceptions exceeding \$10.

The procedures and the associated findings are as follows:

**Cash and Investments**

1. We recalculated the December 31, 2021 and December 31, 2020 bank reconciliations. We found no exceptions
2. We agreed the January 1, 2020 beginning fund balances for each fund recorded in the District's General Ledger and Trial Balance report as well as the Mahoning County Account Detail History Report to the December 31, 2019 balances in the prior year audited statements. We found an unexplained variance of \$22 in the District Fund. We found no other exceptions between the system reports, however, we noted the beginning balances reported in the financial statements filed by the District in the Hinkle System were \$8,183 higher than the amounts reported in the prior year audited statements due to the aforementioned \$22 variance as well as \$8,161 which was mistakenly entered into the beginning balance of Other Funds and offset by Transfers Out in the District and Special Funds. We also agreed the January 1, 2021 beginning fund balances for each fund recorded in the District's General Ledger and Trial Balance report as well as the Mahoning County Account Detail History Report to the December 31, 2020 balances in the District's General Ledger and Trial Balance report as well as the Mahoning County Account Detail History Report. We found no exceptions between the system reports, however, we noted the beginning balances reported in the financial statements filed by the District in the Hinkle System in 2021 were \$95,727 lower than the amounts filed in 2020 due to not entering the balance of the Other Funds and entering the bank balance of the District Fund rather than the reconciled balance.

### **Cash and Investments (Continued)**

3. We agreed the 2021 and 2020 bank reconciliation Adjusted Bank Balances as of December 31, 2021 and 2020 to the total fund cash balances reported in the General Ledger and Trial Balance report as well as the Mahoning County Account Detail History Report and the financial statements filed by the District in the Hinkle System. The amounts did not agree. We noted a variance of \$418 in 2021 and a variance of \$139 in 2020 between the amount reported in the bank reconciliation and the amount reported in the Mahoning County Account Detail History Report for the Special Fund. We also noted a variance of \$104,336 in 2021 between the amounts reported in the bank reconciliation and the amounts reported in the financial statements filed by the District in the Hinkle System. Of this variance, \$95,727 was attributable to incorrectly entered beginning balances in the financial statements, \$8,161 was attributable to Transfers Out that should not have been recorded in the financial statements, and \$448 was attributable to other errors in recording receipts and disbursements in the financial statements. We found no other exceptions.
4. We confirmed the December 31, 2021 bank account depository balances for the District Fund and Other Fund with the District's financial institutions. We found no exceptions. We also agreed the confirmed balances to the amounts appearing in the December 31, 2021 bank reconciliation without exception.
5. We compared the December 31, 2021 Special Fund depository balance from the *Cash Basis Annual Financial Report* to the amount reported in the Mahoning County Account Detail History Report. The amounts differed by \$340.
6. We selected five reconciling debits (such as outstanding checks) from the December 31, 2021 bank reconciliation:
  - a. We footed the supporting outstanding check list and compared it to the cash reconciliation. We found no exceptions.
  - b. We traced each check to the subsequent January and March bank statements. We noted one check for \$111.60 did not clear. We found no other exceptions.
  - c. We traced the amounts and dates to the check register and determined the debits were dated prior to December 31. We found no exceptions.
7. We inspected investments held at December 31, 2021 and December 31, 2020 to determine that they:
  - a. Were of a type authorized by Ohio Rev. Code §§ 135.13, 135.14 or 135.144. We found no exceptions
  - b. Mature within the prescribed time limits noted in Ohio Rev. Code § 135.13 or 135.14. We found no exceptions.

### **Intergovernmental Receipts**

1. We selected a total of five receipts from the State Distribution Transaction Lists (DTL) and the Mahoning County Account Detail History reports from 2021 and a total of five from 2020:
  - a. We compared the amounts from the above named report to the amount recorded in the Mahoning County Account Detail History Report. The amounts agreed.
  - b. We inspected the Mahoning County Account Detail History Report to determine whether the receipt was recorded in the proper year. The receipt was recorded in the proper year. We found no exceptions.



### Other Receipts

We selected 10 other receipts from the year ended December 31, 2021 and 10 other receipts from the year ended 2020 and:

- a. Agreed the receipt amount recorded in the General Ledger Report to supporting documentation. The amounts agreed.
- b. Confirmed the amount charged complied with rates in force during the period, if applicable. We found no exceptions.
- c. Inspected the General Ledger Report to determine the receipt was posted to the proper funds, and was recorded in the proper year. We found no exceptions.

### Payroll Cash Disbursements

1. We selected one payroll check for all employees from 2021 and one payroll check for all employees from 2020 from the Mahoning County – Prelist Report and:
  - a. We compared the hours and pay rate, or salary recorded in the Mahoning County – Prelist Report to supporting documentation (timecard, legislatively or statutorily-approved rate or salary).
    - i. We inspected the minute record for the Retirement system, Federal, State & Local income tax withholding authorization.
    - ii. We agreed these items to the information used to compute gross and net pay related to this check.  
We found no exceptions.
  - b. We inspected the Mahoning County – Prelist Report to determine whether salaries and benefits were paid only from the *Special Fund*, as required by the SWCD Administrative Handbook Chapter 5. We found no exceptions.
  - c. We inspected the Mahoning County – Prelist Report to determine whether the check was classified as *salaries* and was posted to the proper year. We found no exceptions.

### Non-Payroll Cash Disbursements

1. We selected five disbursements from the *Special Fund* and five disbursements from the *District Fund* and other funds from the Account Detail History Report for the year ended December 31, 2021 and five from the *Special Fund* and five from the *District Fund* and other funds for the year ended 2020 and determined whether:
  - a. The disbursements were for a proper public purpose. We found no exceptions.
  - b. For *District Fund* and other funds disbursements, we determined whether:
    - i. The check number, date, payee name and amount recorded on the returned, canceled check agreed to the similar data recorded in the General Ledger and to the names and amounts on the supporting invoices. We found no exceptions.
    - ii. The payment was posted to a fund consistent with the purpose for which the fund's cash can be used. We found no exceptions.
  - c. For *Special Fund* disbursements, we determined whether:
    - i. The payee name and amount recorded on the invoice submitted to the County Auditor agreed to the payee name and amount recorded in the Account Detail History Report and County Ledgers. We found no exceptions.
    - ii. The invoice was signed by the fiscal officer and approved by a majority of the Board of Supervisors. We found no exceptions.

### Special Fund Budgetary Compliance

1. We inspected the District's Special Fund Budget Request submitted to the County Commissioners for the years ended December 31, 2021 and 2020. The request included the Special Fund's *Needs*, *Income* and *Balances* anticipated for carry over from the current year, as required by the SWCD Administrative Handbook, Chapter 5. We also compared the budget amounts to the Special Fund Budgetary Activity footnote of the Cash Basis Annual Financial Report. The amounts did not always agree.
2. Ohio Rev. Code § 5705.41(B) prohibits expenditures (disbursements plus year-end certified commitments) from exceeding appropriations. We compared total expenditures to total approved appropriations (Ohio Rev. Code §§ 5705.38 and 5705.40) plus any carryover appropriations for the year ended December 31, 2021 and 2020 for the "Special" Fund. Expenditures did not exceed appropriations for the Special Fund.
3. We compared interfund transfers-in to transfers-out to ensure they agreed and inspected the transfer activity to determine they were approved by the Board of Supervisors. We noted transfers-in and transfers-out did not agree in 2021 and 2020. The amounts reported as transfers-out in 2021 and 2020 should not have been included in the Annual Cash Basis Financial Reports as the amounts in 2020 were offsetting a beginning balance variance noted in Cash and Investments Procedure 2. The amounts in 2021 were entered in error as noted in Cash and Investments Procedure 3.
4. We inspected the Annual Cash Basis Financial Report for the years ended December 31, 2021 and 2020 for negative cash fund balances. Ohio Rev. Code § 5705.10 (I) provides that money paid into a fund must be used for the purposes for which such fund is established. As a result, a negative fund cash balance indicates that money from one fund was used to cover the expenses of another. There were no funds having negative cash fund balances.

### Sunshine Law Compliance

1. We obtained and inspected the District's Public Records Policy to determine the policy was in accordance with Ohio Rev. Code §§ 149.43(E)(2) and 149.43(B)(7)(c) and did not limit the number of responses that may be made to a particular person, limit the number of responses during a specified period of time, or establish a fixed period of time before it will respond unless that period is less than eight hours. We found no exceptions.
2.
  - a. We inquired with District management and determined that the District did not have any completed public records requests during the engagement period.
  - b. The District did not have any denied public records requests during the engagement period.
  - c. The District did not have any public records requests with redactions during the engagement period.
3. We inquired whether the District had a records retention schedule, and observed that it was readily available to the public as required by Ohio Rev. Code § 149.43(B)(2). We found no exceptions.
4. We inspected written evidence that the Public Records Policy was provided to the records custodian/manager as required by Ohio Rev. Code § 149.43(E)(2). We found no exceptions.
5. We inspected the District's policy manual and determined the public records policy was included as required by Ohio Rev. Code § 149.43(E)(2). We found the District had a policy manual but did not include the public records policy.

### **Sunshine Law Compliance (Continued)**

6. We observed that the District's poster describing their Public Records Policy was displayed conspicuously in all branches of the District as required by Ohio Rev. Code § 149.43(E)(2). We found no exceptions.
7. We inquired with District management and determined that the District did not have any applications for record disposal submitted to the Records Commission during the engagement period.
8. We inspected individual proof of attendance and determined whether each elected official in accordance with Ohio Rev. Code § 149.43(E)(1) (or his/her designee) successfully attended a certified three-hour Public Records Training for each term of office as required by Ohio Rev. Code § 109.43(B). We found no exceptions.
9. We inspected the public notices for the public meetings held during the engagement period and determined the District notified the general public and news media of when and where meetings during the engagement period were to be held as required by Ohio Rev. Code § 121.22(F). We found no exceptions.
10. We inspected the minutes of public meetings during the engagement period in accordance with Ohio Rev. Code § 121.22(C) and determined whether they were:
  - a. Prepared – a file is created following the date of the meeting
  - b. Filed – placed with similar documents in an organized manner
  - c. Maintained - retained, at a minimum, for the engagement period
  - d. Open to public inspection – available for public viewing or request.We found no exceptions.
11. We inspected the minutes from the engagement period in accordance with Ohio Rev. Code § 121.22(G) and determined the following:
  - a. Executive sessions were only held at regular or special meetings.
  - b. The purpose for the meetings and going into an executive session (when applicable) correlated with one of the matters listed in Ohio Rev. Code § 121.22(G).
  - c. Formal governing board actions were adopted in open meetings.We found no exceptions.

### **Other Compliance**

1. Ohio Rev. Code § 117.38 requires Districts to file their financial information in the HINKLE system within 60 days after the close of the fiscal year. This statute also permits the Auditor of State to extend the deadline for filing a financial report and establish terms and conditions for any such extension. Auditor of State established policies, regarding the filing of complete financial statements, as defined in AOS Bulletin 2015-007 in the Hinkle System. We confirmed the District filed their complete financial statements, as defined by AOS Bulletin 2015-007 and Auditor of State established policy, within the allotted timeframe for the years ended December 31, 2021 and 2020 in the Hinkle system. We found no exceptions

We were engaged by the District to perform this agreed-upon procedures engagement and conducted our engagement in accordance with the attestation standards established by the AICPA and the Comptroller General of the United States' *Government Auditing Standards*. We were not engaged to, and did not conduct an examination or review engagement, the objective of which would be the expression of an opinion or conclusion, respectively, on the District's receipts, disbursements, balances and compliance with certain laws and regulations. Accordingly, we do not express an opinion or conclusion. Had we performed additional procedures, other matters might have come to our attention that would have been reported to you.

We are required to be independent of the District and to meet our ethical responsibilities, in accordance with the ethical requirements established by the Comptroller General of the United States' *Government Auditing Standards* related to our agreed upon procedures engagement.
