INDEPENDENT ACCOUNTANT'S REPORT ON APPLYING AGREED-UPON PROCEDURES

We have performed the procedure described below on the Meigs Metropolitan Housing Authority, Meigs County, Ohio (the Authority), solely to assist them in determining whether the electronic submission of certain information agrees with related hard copy documents included within the reporting package. The Authority is responsible for the accuracy and completeness of the electronic submission.

We were engaged to perform an audit of the financial statements, for the Authority as of and for the year ended September 30, 2022, and have issued our reports thereon dated October 4, 2023. The information in the "Hard Copy Documents" column was included within the scope, or was a by-product of that audit. Further, our opinion on the fair presentation of the Financial Data Schedule (FDS) dated October 4, 2023, was expressed in relation to the basic financial statements of the Authority taken as a whole.

This agreed-upon procedure engagement was conducted in accordance with attestation standards established by the AICPA. The procedures performed do not constitute an audit (or a review) of the financial statements or any part thereof, the objective of which is the expression of an opinion (or conclusion) on the financial statements or a part thereof. Accordingly, we do not express an opinion or conclusion. Had we performed additional procedures, other matters might have come to our attention that would have been reported to you.

A copy of the financial statement package and the FDS which included the auditor's reports, is available in it's entirely from the Authority. We have not performed any additional auditing procedures since the date of the aforementioned audit reports. Further, we take no responsibility for the security of the information transmitted electronically to the U.S. Department of Housing and Urban Development, REAC.
